JamEra SERVICE AGREEMENT
 MOBILE MUSIC

1. Fee agreed upon is based on a **FOUR HOUR MINIMUM** charge. Regardless of reason, **NO REFUND will be given if your event ends before the contracted end time.**
2. **Party #1** agrees that the **DJ services will completely cease at the end of contracted time.** If **Party #1** wishes to resume disc jockey services past the contracted length, additional penalty charges of **\$150/hr** will incur for each hour past the original end time.
3. **Party #1** will make payments as follows: **\$100** deposit to hold date and the remainder **of the balance due to be paid in FULL to disc jockey on the day of the event.**
4. **Party #1** shall at all times have complete supervision, direction and control over the services provided by this agreement and the ends to be accomplished as long as they are in keeping with accepted professional practices and equipment capabilities.
5. The liability of **JamEra Mobile Music** to perform said services is subject to proven detention by sickness, accidents, or any other actions not under its control.
6. This agreement may be canceled by either party only on written notice at least **14** days prior to the engagement noted above. Burden of proof of cancellation will be on the canceling party. Cancellation by **JamEra Mobile Music** will result in full refund of **all** payments including deposit. Timely cancellation by **Party #1** will result in the refund of all payments received **by JamEra Mobile Music** less the **\$100** deposit. If **Party#1's** event is booked on short notice (**less than 14 days from event**), then either party may cancel on written notice **48 hours** prior to event.
7. All payments made towards the obligations stated in this agreement except as outlined in paragraph **(6) six**, will be **non-refundable.**
8. **Party #1** agrees to pay the balance due on the date of the event. Failure to do so will result in forfeiture of any discounts and a minimum **\$25** additional billing to cover time and expense for collection.
9. The liability of **JamEra Mobile Music/Ray Evangelista**, shall not exceed the amount of payments received by **Party#1.**
10. **Party #1** agrees to assume complete liability for all claims of personal injury or property damage arising from the engagement(s) noted herein and hold **JamEra Mobile Music** harmless in all such cases, except when caused by an employee/agent of **JamEra Mobile Music.**
11. **Party #1** agrees to maintain adequate security in the service and access areas so as to protect the property of **JamEra Mobile Music** from theft, vandalism or other damage. Failure to provide adequate security and order of your event will result in early cancellation of music services without a refund.
12. **Party #1** also agrees to be fully responsible for supplying adequate local power, tables and a setup location that is protected from the elements of weather and free from any environmental or structural hazards. **JamEra Mobile Music WILL NOT setup equipment outdoors** without adequate equipment protection.
